# New Program: Pathways to Permanent Housing

On January 1st, 2017, Guest House of Milwaukee began managing the Pathways to Permanent Housing program located on the South Side of Milwaukee. This residential program provides transitional housing to 27 chronically homeless individuals. While in this program, residents have the unique opportunity to develop independent living skills and work towards permanent supportive housing.

For program manager lesha Sprewell, Pathways to Permanent Housing is a great step for Guest House.

"Pathways is important to the work Guest House is doing because we strive towards the same goal of providing housing, treatment, and social services for homeless individuals," she said.

Guest House is excited that our growth as an organization continues to allow us to better serve those in our city who need us most.



## Our Garden is Growing!

If you've ever visited Guest House, one of the things that probably stuck out to you was the Cream City Garden. Across the street from Guest House, on an acre plot of land, sits our community garden. The Cream City Garden was a project started in 2010 as a way of providing fresh produce to our community and to provide valuable training and skill-building for our guests and clients.

In the past seven years, the garden has grown in both size and sophistication, and in 2017 we created a new staff position to accommodate and facilitate garden planning and volunteers. Kaitlin Downs was hired as Guest House's first Garden Tech, and proved to be a valuable resource not only for our garden, but for Guest House as a whole.

In her role of Garden Tech, Kaitlin was able to lead and teach volunteers about gardening, as well as be an enthusiastic advocate for Guest House.
